<p><b>Ministry of MSME, Government of India</b> has formulated “<b>Scheme of Fund for Regeneration of Traditional Industries (SFURTI)</b>”, for the development of Village industries and Coir clusters in order to organize the traditional industries and artisans for their growth and long term sustainability. <b>Foundation of MSME Clusters (FMC)</b> is the Nodal Agency for the development of clusters under the scheme, undertakes the role of programme fund management, in addition to monitoring and evaluation of project implementation.</p> <p>The scheme specifies the following institutional arrangement at the operational level:</p> <ul style="list-style-type: none"><li>➤ a Special Purpose Vehicle (SPV) be formed to develop and manage the cluster</li><li>➤ an Implementing Agency (IA) is appointed to undertake scheme implementation</li><li>➤ a Technical Agency (TA) is designated to assist and guide the scheme implementation</li></ul> <p><b>Chikkaballapur Zari &amp; Multi product Cluster</b> is approved under the scheme. <b>M/s.Chikkaballapur Artisans Welfare Association</b>, having its registered office at <b>Thiranahally Village, Chikkaballapur Taluk and District</b> is the Special Purpose Vehicle (SPV) of the Cluster. <b>M/s.Sri Nandi Khadi Gramodyoga Sangha</b> is the Implementing agency of the cluster and <b>M/s.ITCOT Consultancy and Services Limited</b> is the designated Technical agency for the cluster.</p> <p>The scheme envisages establishment of upgraded production infrastructure, as the Common Facility Center (CFC), for the manufacturing of Zari &amp; multi products and stipulates the building construction and machinery procurement for the establishment of CFC should adhere the General Financial Rules (GFR) of Government of India. **The tender comprises of 2 packages.** The Tender for each package have to be submitted separately and **each package will be considered as separate tender.** The tenderer can bid one or more packages subject to fulfillment of eligibility criteria for the respective package. The successful bidder to be selected through this tender is expected to undertake supply, erection and commissioning of machineries, equipments and its accessories as specified, for each package, in the tender. The Tender notification has been published fixing the date of opening of tender as 18.09.2020 at 03.00 PM.

## 2. SCOPE OF WORK

- a) The successful tenderer should undertake supply, erection and commissioning of machineries, equipments and its accessories for the common facility centre of Chikkaballapur Zari & Multi product Cluster on turnkey basis. The tender comprises of 2 packages and the details are given hereunder:

## 11. EARNEST MONEY DEPOSIT

(a) The Tender should be accompanied by an Earnest Money Deposit (EMD) in the form of Account Payee Demand Draft drawn on any Indian Nationalized/Scheduled Commercial Bank in favour of “Sri Nandi Khadi Gramodyoga Sangha”, payable at Bengaluru, EMD for each package is given below:

(b) The EMD in any other form will not be accepted. The Earnest Money Deposit will be returned to the unsuccessful tenderers at the earliest on the expiry of final bid validity and latest on or before the 30<sup>th</sup> day of the award of contract.

(c) The Earnest Money Deposit will be retained in the case of successful tenderer and it will not earn any interest and will be dealt with, as provided in the terms and conditions of the tender.

(d) Any request of the tenderer, under any circumstances claiming exemption from payment of EMD will be rejected and their Part II Price offer will not be opened.

(e) If the tenderer emerges as the successful bidder and after subsequent issuance of letter of acceptance by the IA, failure to sign the agreement, to remit the Security Deposit or to execute the contract as per tender conditions, will result in the forfeiture of the EMD amount remitted.

## 12. VALIDITY

(a) The rate quoted in the Tender should be valid for the acceptance by the IA for a minimum period of 90 days from the date of opening of the Tender.

(b) The accepted rate of the successful tenderer is valid till the entire contract is fully completed. Escalation in the rates will not be entertained under any circumstances.

## 13. OPENING AND EVALUATION OF THE TENDER

(a) The tender box will be closed at 01.00 PM as per the office clock on **Friday 18<sup>th</sup> September 2020** and the received tenders in the tender box will only be opened.

Tenders received after specified date and time will not be accepted. The Tender will be opened by the Tender committee at 03.00 PM on the same day in the presence of the available tenderers/ representatives of the Tenderers who choose to be present. **The venue of the Bid opening shall be at Ms./Sri Nandi Khadi Gramodyoga Sangha, No-108-F, M.LA.Layout, 5<sup>th</sup> Cross, Bhoopsandra, Bengaluru – 560094.** The Tenderers or their authorized agents are allowed to be present at the time of opening of the tenders.

- (b) Tender Committee will inform the attested and unattested corrections, before the Tenderers and sign all such corrections in the presence of the Tenderers. If any of the Tenderers or agents not present then, in such cases the Committee will open the tender of the absentee Tenderer and take out the unattested corrections and communicate it to them. The absentee Tenderer should accept the corrections without any question whatsoever.
- (c) If the date fixed for opening of the tender happens to be a Government holiday, the sealed tenders will be received up to 01.00 PM on the next working day and opened at 03.00 PM on the same day.

<b>17.</b>	<b>SECURITY DEPOSIT</b>

- (d) If the contract is not completed within the stipulated time or extended time, Tender Committee will hold full authority to cancel the tender or take any such action that will be deemed fit to the occasion at the risk and cost of the successful tenderer.
